**INVITATION TO BID FOR THE PROCUREMENT
OF THE OFFICIAL SERVICE VEHICLE OF THE
PHILIPPINE EMBASSY IN HANOI, VIETNAM**

1. The Philippine Embassy in Hanoi, through Republic Act No. 10924 or the General Appropriations Act of FY 2017 dated 22 December 2016 and under authority from the Office of the President dated 10 October 2017 on the purchase of luxury motor vehicles (LMV), intends to apply the sum of **One Million Seven Hundred Ninety Three Thousand Three Hundred Sixty Fives Pesos (Php 1,793,365.00)** or approximately **Thirty Six Thousand Three Hundred US dollars (US\$36,300.00)**, being the Approved Budget for the Contract (ABC) to payments under the contract for the “**Procurement of Philippine Embassy’s Service Vehicle**”. Bids received in excess of the ABC shall be automatically rejected at bid opening.
